Fun fact: Rob is an avid philatelist – a stamp collector - and has been for over 40 years, having accrued quite an extensive collection.


Taylor Takes Clinical Reins

Sarah Manning Interview



Q: What made you decide to take over the Administrator position at Meadows of Scioto?

A: There were a couple of factors that moved me to decide to take over as an Administrator at Scioto. First and foremost, there was a need. The previous Administrator had resigned. Q: What is your current role like?

Home Care Leaders Earn Ohio, National Certification

Lisa Brown, Chief Operating Officer and Leanne Frampton, Administrator of Capital Health Home Care Ashtabula & Solon, have successfully completed the Certified Executive for Home Care & Hospice (CEHCH) certification program offered through the Ohio Health Care Association. They have also passed the NAB (National Association of Long-Term Care Administrator Boards) Home & Community Based Services Examination to garner the CEHCH designation.

Ohio CEHCH is a comprehensive certification program intended to elevate the skills and professionalism of home care, hospice, and community-based services executives in Ohio, by combining national competency standards with Ohio's most comprehensive state-specific training.

The CEHCH Training Course is a combination of interactive classroom training, guided self-study, and hands-on clinical learning.

Following the four-day CEHCH Training Course, candidates must complete the NAB Examination to be awarded the CEHCH distinction. The Ohio CEHCH is awarded to candidates based on 100 percent class participation, including completion of in-class quizzes, testing, and successful passage of the NAB Examination.

The program is designed for experienced home care, hospice and community-based services executives looking for a competitive edge in the marketplace, or those interested in obtaining the necessary skills to successfully lead their organizations in Ohio or nationwide.

Although Ohio does not currently require certification for home care, hospice, and community-based services executives, CEHCH has aligned its program curriculum with the NAB Home and Community Based Services Examination Licensing Examination, so that credentialed home care, hospice and community-based services executives in Ohio meet national competency standards.

Lisa Brown has worked for Capital Health for the past 25 years, previously serving as a Director of Nursing and Administrator, and is currently at the corporate level, leading operations of Home Care, Hospice and Senior Living.

Leanne Frampton has been with Capital Health for five years and leads the operations of our Ashtabula and Solon Home Care agencies. Leanne has a strong background in sales and marketing and operational leadership.



Capital Health Assisted-Living Executive Garners Ohio, National Certification

Jamie Herald, a Steubenville Assisted Living Administrator, has completed the training program and examination for assisted-living executives in Ohio, and has been awarded an Ohio Certification.

Herald, a LNHA at Carriage House and Carriage Inn of Steubenville, has completed the Certified Executive for Assisted Living (CEAL) certification program offered through the Ohio Health Care Association (OHCA), and has passed the NAB (National Association of Long Term Care Administrator Boards) Residential Care/Assisted Living Administrators Examination to earn the CEAL designation.

Herald has worked at Carriage House and Carriage Inn of Steubenville for the past four years. She has been a manager for Capital Health Care for more than 12 years and became a Licensed Nursing Home Administrator in 2018. She holds a Bachelor of Science in Human Resources from Franklin University.

CEAL is a comprehensive certification program designed to elevate the skills and professionalism of assisted-living administrators in Ohio by providing a national certification, along with Ohio's most comprehensive state-specific training.

The CEAL Training Course is a combination of interactive classroom training, guided self-study and hands-on clinical learning.

Following the four-day CEAL Training Course, candidates must complete the NAB Examination to be awarded the CEAL designation. The Ohio CEAL is awarded to candidates based on 100 percent class participation, including completion of in-class quizzes, testing, and successful passage of the NAB Examination.

Since 2013, OHCA has trained more than 300 students nationally who have earned their CEAL designation. The program is designed for experienced assisted-living executives looking for a competitive edge in the marketplace, or those interested in obtaining the necessary skills to successfully lead an assisted-living building in Ohio or nationwide.

Although Ohio does not currently require certification for assisted-living administrators, CEAL has aligned its program curriculum with the NAB Residential Care/Assisted Living Administrators Licensing Examination, so that credentialed assisted-living executives in Ohio meet national competency standards and are well positioned for any future changes to Ohio's RCF administrator requirements.
